Managing Invisible Boundaries: How “Smart” is Smartphone Use as a Boundary Management Tactic?

ABSTRACT

Smartphone use has become a ubiquitous part of daily life, and its use has been shown to be associated with a variety of outcomes, both positive and negative. One of the most interesting areas of research is the use of smartphones as a boundary management tactic. This paper examines the use of smartphones as a boundary management tactic and its relationship to work-life balance, stress, and well-being. The study uses a sample of 1,000 employees and finds that smartphone use is associated with higher levels of work-life balance, lower levels of stress, and higher levels of well-being. The study also finds that the use of smartphones as a boundary management tactic is more likely to be used by employees who are high in self-regulation and who have a high level of work-life balance. The study has several implications for practice and research. First, it suggests that organizations should encourage employees to use smartphones as a boundary management tactic. Second, it suggests that organizations should provide training and support to help employees use smartphones effectively. Third, it suggests that researchers should continue to explore the relationship between smartphone use and work-life balance, stress, and well-being.
